## A BRIEF DESCRIPTION OF WHAT THE FED DOES

The Federation is the national organisation of tenants, residents, leaseholders and service users (referred to as tenants) in Riverside. The Executive Committee is the body which represents all Riverside tenants at a national level. Members are selected by their Riverside Divisions to serve on the Executive for a three year term of office.

The Executive acts as Riverside's "critical friend" – independent but working in partnership with Riverside and strives to ensure tenants' views and concerns are properly heard and taken into account at all levels of the organisation, from neighbourhood shop to Riverside's Group board. It is part of the decision making process for Riverside and its tenants and residents on policy, service delivery and strategy.

### WHAT WAS AGREED

- Update on Riverside's Target Operating Model noted the proposed changes and locations for Front Line Service Delivery in Social Housing announced on 26 April 2017. Housing Officer roles to be primarily patch based with the patch to be determined by stock distribution and Tenancy Intelligence Model analysis. There is an expectation on Front Line Service Delivery to promote channel shift/fuller use of the Customer Service Centre to focus more on customers who need face to face contact. Noted the proposed implementation dates:
  - 23 October Front Line Service Delivery and Housing Shared Services in Irvine, North and South & Central, together with some of the Housing Services Processing in Liverpool City Region
  - 27 November 2017 Front Line Service Delivery and the rest of Housing Shared Services teams in Liverpool City Region

Federation expressed concern about lack of communication and a perception from some customers that the Federation is not sharing information. Noted that the detail of JW's presentation was confidential but agreed to disseminate information about the re-organisation of Front Line Service Delivery in Social Housing. Asked Riverside to ensure that customers are kept informed about changes to local offices.

- Federation Scrutiny Panel Report on Property MOTs Noted the key issues found and recommendations made by the Liverpool City Region and Cumbria scrutiny panels. Agreed to ask the Federation Scrutiny Panel to consider undertaking a national scrutiny exercise on Property MOTs. Thanked the Scrutiny Panel for producing a good report.
- Any Other Business Customer Involvement Staffing Changes from 10 July 2017 – Noted that Mark Hoskisson (Resident Involvement Manager) and Sharon Hutchinson (Resident Involvement Officer) would no longer be working with the formal involvement structure from 10 July 2017.
