1. Introductions & Purpose of the Meeting:

3. Outline Programme October 2017-July 2018

- a) Noted that Riverside's priorities from October to December 2017 are to;

- Agree the process and timetable for recruitment of the Independent Tenants' Advisor (ITA) and to start the process
- Agree and circulate the Residents charter
- b) Noted that Riverside's priorities from January to March 2018 are to;

- Appoint contractor/developer for the delivery of the new estate
- Riverside & contractor/developer to start design work for a planning application for the new estate
- Riverside & contractor to arrange visit to an estate to show design options

- b) RSG members were informed that the successful ITA will have experience of working on similar housing association estates across London and will submit bids based on their approach to completing key tasks set out within the brief.
- c) RSG members interested in being involved with the selection of the ITA will have the opportunity to do so. Further information on how RSG members can be involved will be provided once the ITA brief has been issued.
- d) Riverside RSG Code of Conduct to be circulated.

6. Any Other Business

- a) RSG members were keen to work with Riverside on the appointment of the ITA and the need for consistent and independent tenants' advice was welcomed.
- b) Residents were informed that estate wide Housing Need Survey letters will be issued in the next couple of weeks.
- c) The importance of the Housing Needs Survey was reinforced and residents were encouraged to make an appointment at a convenient time so that Riverside can gather information on residents' individual housing needs and rehousing requirements.
