#### **TENANCY AUDITS**

Over the coming months we will be conducting tenancy audits across the estate. The tenancy audits are important as they ensure we have captured the most up to date information about you and your family, and more importantly, it will allow us to build you a home that meets your needs.

#### **PARKING UPDATE**

As you know we will be suspending onsite parking this summer/autumn. We have listened to resident concerns about the full suspension of parking and are working with Bellway to retain some onsite parking. We will keep you updated on progress.

We also made a commitment to you during the ballot, to provide those residents that currently have a parking permit with a CPZ parking permit for the surrounding roads, when parking is suspended.

To ensure we hold the correct data for parking permits we will be carrying out a parking audit to understand who was issued with a permit in October 2021.
