On Monday 17 October, we asked you to take part in a second resident vote to understand if you are supportive of the redevelopment of Friars Close and Burrell Street. We want to thank everyone who has been engaging with us about the design proposals and had their say on the future of your estate in the second resident vote.

The vote has now closed, and we are pleased to announce that **93%** of you participated in the vote.

All votes were independently collected and verified by Open Communities to provide a fair and transparent process. Of the votes cast, the outcome was as follows.

# Join us for a night walk

To better understand how you experience Friars Close and Burrell Street in the evenings and at night, Mount Anvil are organising a night walk on the estate, led by their specialist lighting consultant 'Light Follows Behaviour.'

#### Thursday 17 November, 7:00-8:00pm Friars Close courtyard.

Lighting is a crucial element of design and, during the consultation, some of you have told us you don't always feel safe outside on the estate at night. The walk is a crucial next step in improving this.

Through analysis and discussion, we will look at where the lighting is currently successful and unsuccessful and how it could be improved. The residents' feedback gathered at the event will inform the final lighting strategy for the proposed regeneration of the estate.

To ensure everyone can take part, we will have two groups. One will take part in the walking exercise and the other will stay in the courtyard. So if you don't want to walk or feel unable to do so, you can still come along and have your say.
